Information on Interstate Compacts from the Chairman

As a member of the advisory committee on Interstate Compacts for Speech Language Pathology and Audiology, I want to take this opportunity to address some of the information presented to the drafting team.

An Interstate Compact is an agreement between states, which creates a pathway for licensure to qualified audiologists and speech language pathologists who wish to practice in multiple states. Interstate Compacts date back to 1662. An Interstate Compact is a mechanism for states to jointly problem solve, often avoiding federal intervention.

Congress has been comprehensively reviewing ways to expand appropriate use of telehealth services to alleviate current and future provider shortages. Should a federal mandate occur, speech language pathologists and audiologists would not be allowed to design the legislation and Alabama would be required to fund it. An Interstate Compact allows the states to maintain their sovereignty.

The Interstate Compact will serve to lessen the burden of those serving patients in multiple states by allowing them to have one license for multi-state practice. This will benefit those using other modes of practice such as teletherapy as well.

There are 215 Interstate Compacts presently. Physicians in Alabama joined the Interstate Compact last year. Psychologists, Nurses and Physical Therapists all participate in Interstate Compacts.

I appreciate all who completed the questionnaire distributed during the ABESPA forum at SHAA this year. 150 surveys were distributed and 78 were returned (52%). Sixty four percent of the professionals stated that they could foresee participating in the Interstate Compact. The majority of those responding reported that they would be in favor of Alabama participating in an Interstate Compact.

The process for development of an Interstate Compact is usually phased over 3-4 years. The drafting team presently is utilizing recommendations made from the advisory committee. ABESPA with SHAA's support will be needed to undergo the legislative changes required to implement an Interstate Compact.

Continuing Education FAQ's

Do I have to get ABESPA's permission to attend a conference?

Do I need preapproval of every continuing education activity that I want to attend?

Can I only attend ABESPA-approved continuing education activities?

No, No, and No

Licensees are referred to the section of the Alabama Administrative Code 870-X-4-.08 entitled "Mandatory Continuing Education". This section of the Code gives the Continuing Education Requirements for license renewal.

Reminders-

Twelve (12) hours must be in compliance with the content area requirements. Twenty-four (24) hours are required for dual licenses.

A minimum of ten (10) hours must improve professional **clinical** competency (Content Area I). *Ethics falls under this Content Area and is highly recommended.*

A maximum of two (2) hours can be in an area related to the area of licensure but must improve professional competency (Content Area II).

The licensee should possess the professional ability to identify the continuing education activities which will improve his/her own level of clinical competency. Verification of attendance at these continuing education activities is the responsibility of the attendee and documentation would be included for audit purposes.

If there is a question about the Content Area and the licensee wants preapproval **prior** to attending the event, an application can be submitted to the Board. See the ABESPA website for the preapproval application form.

Remember-Continuing education improves clinical competency and benefits the consumer of these services.

Credential Review

The Credential Review Committee is charged with investigating complaints of possible violations of the Alabama law governing speech-language pathology and audiology licensure. The committee monitors correspondence from the complainant and licensee. The Assistant Attorney General oversees the steps in the investigation.

If you know that someone has violated the Rules and Regulations and/or the Code of Alabama; or has engaged in illegal practice; or provided services which place the consumer at risk, a complaint can be filed to the Board. The complaint form is located on the ABESPA website under downloadable forms.

The ABESPA Board offers an Ethics seminar for continuing education credit annually at the SHAA Convention. Address any questions you have concerning this subject to the Board office.

The role of the Applications Committee is to review and determine the status for the following application categories:

- ✓ Annual audited SLP and AUD license renewals
- ✓ New licensees either applying from out-of-state or completing SLP-CF/4th Year AUD placements
- ✓ SLP-CF/4th Year AUD Intern registration
- ✓ SLP-A registration

The Board only reviews applications at each monthly meeting, so it is important for licensees to renew licenses promptly between October and December 31st each year.

Rules and Regulations Committee Report

The Rules and Regulations Committee reviews current rules and regulations in order to keep our standards current as our respective fields evolve. The primary mission of this board is to safeguard the services being provided to the consumers of the state. This requires periodic changes to maintain appropriate regulatory authority over practicing professionals so that the consumers are adequately served.

While the board attempts to keep current with the changing landscape of regulatory guidelines, we also appreciate the input of our dedicated professionals. If any licensee knows of an area where we might have a need to improve our rules and regulations, we certainly invite and appreciate the input in order to maintain a relevant code of practice. The most recent rule change proposed to our Rules and Regulations concerns the timely reporting of actions of another licensure board of criminal activity convictions against a licensed member. The new regulation will be added to Rule 870-X-2-.02 as Item 6 as follows.

Rule 870-X-2-.02

(6): Each licensee shall notify the board in writing by certified mail within 30 days after he/she receives notice of :

- a. A disciplinary action by another licensure board in another jurisdiction; or
- b. Any criminal conviction, misdemeanors, or felonies from the State of Alabama or another jurisdiction. Failure to notify the board of such will result in disciplinary action as stated in Section 870-X-5-.01, est. seq. of the ABESPA Rules and Regulations.

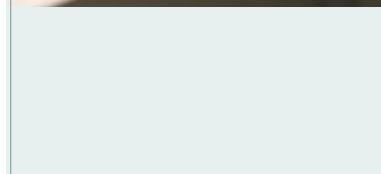
The proposed rule change will be submitted to the Alabama Administrative Monthly prior to the June 20th deadline for June 29th publication. The Public Hearing will tentatively be scheduled for August 10th and tentatively effective October 5th.

What is the law in Alabama on Telepractice?

ABESPA Rules & Regulations § 870-X-2-.01(j):

“Any practitioner who does not meet the exemptions stated above must hold an Alabama license. **This shall be required for all individuals providing services for consumers in Alabama via in-office practice as well as Telepractice or any other electronic means.**”

Note:

- All licensure provisions (face-to-face) apply to Telepractice procedures.
- Check the provider/insurance requirement for the proper procedure when billing for services.

Can a person, who is not licensed, perform speech-language pathology or audiology services via Telepractice? *Answer: It depends on if the practitioner works in an exempt setting or receives special permission ...*

ABESPA Rules & Regulations § 870-X-2-.01(d): Exempt Setting

- The activities and services of a person who holds a valid and current credential as a speech and/or hearing specialist issued by the Department of Education of this State or
- A person, who is employed as a speech-language pathologist or audiologist by the Government of the United States.
- **If such person performs speech-language pathology and audiology services solely within the confines or under the jurisdiction of the organization by which he/she is employed.**

***EXEMPTION APPLIES ONLY IF THE DUTIES ARE PERFORMED SOLELY WITHIN THE CONFINES OF THE JURISDICTION BY WHICH HE/SHE IS EMPLOYED.**

****This provision DOES NOT exempt persons who perform speech-language pathology and audiology services outside the confines or jurisdiction of the Department of Education of this state or the Government of the United States.**

*****The exempt person can only share research or provide lectures outside of duties without being licensed. THEY CANNOT PROVIDE CLINICAL DIAGNOIS OUTSIDE OF WORK SETTING WITHOUT BEING LICENSED.**

ABESPA Rules & Regulations § 870-X-2-.01(g-h): Special Permission

- Sections (g) and (h) provide for an exemption for practitioners, who do not reside in Alabama, to receive a limited clearance to provide speech-language pathology or audiology service with the association of a licensed Alabama SLP or AuD.
- Section (i) requires mandatory notification of ABESPA for anyone seeking to provide speech-language or audiology services pursuant to the limited exemptions provide in sections (g) & (h).
- The out-of-state practitioner **MUST** complete the Telepractice Form for limited practice. The form is available on ABESPA’s website: <http://abespa.alabama.gov> .

When using Telepractice for speech-language pathology or audiology services, consider the following:

- Ensure computer connection is available;
- Ensure that the patient is clear on the service provided;
- Receive waivers for privacy, if needed;
- Make sure that the HIPPA/IEP documentation are current and allow Telepractice treatment
- Receive clearance from health care provider that the Telepractice service will be covered by insurance or paid by the patient
- Determine how you will deliver the Telepractice service, via computer, telephone, or hybrid.
